Barry Sloane, Chairman, President and Chief Executive Officer commented, "We are pleased to be able to raise our 2019 annual dividend forecast to \$1.95 per share from the recent upward revision of \$1.90 per share. All material metrics from our underlying businesses have been and are anticipated to be in line with higher than expected earnings for the company and, as a result, we are comfortable with increasing our 2019 annual dividend forecast. We are excited to announce our second quarter 2019 financial results on Tuesday, August 6, 2019 and look forward to our investors joining the earnings conference call the following day."

Note regarding Dividend Payments: The Company's Board of Directors expects to maintain a dividend policy with the objective of making quarterly distributions in an amount that approximates 90 - 100% of the Company's annual taxable income. The determination of the tax attributes of the Company's distributions is made annually as of the end of the Company's fiscal year based upon its taxable income for the full year and distributions paid for the full year.
