Use of Proceeds:	The Company intends to use the net proceeds from this offering to fully redeem the outstanding 2022 Notes, which mature on September 30, 2022 and bear interest at a rate of 7.50%. As of July 24, 2019, we had outstanding 2022 Notes with an aggregate principal amount of approximately \$8.3 million plus accrued and unpaid interest. We intend to use the net proceeds remaining after we redeem the 2022 Notes to increase our SBA 7(a) lending activity and to make direct investments in portfolio companies (including, from time to time, acquiring controlling equity interests in portfolio companies) in accordance with our investment objectives and strategies described in this prospectus supplement. We will also pay operating expenses and may pay other expenses, such as due diligence expenses of potential new investments, as well as for general working capital, from the net proceeds from the sale of our securities pursuant to this prospectus supplement.
